2. If any fault due to materials not being of merchantable quality or fit for their purpose from the date of completion of the above works, Concord Industrial Coatings Pty Ltd will, at its own cost, replace the product for the project to be re-sealed.
3. If any damage does occur to the finished product, Concord Industrial Coatings Pty Ltd is to be notified in writing immediately, and a representative must be granted access in a timely manner to sight the damage and assess the cause, to ensure that any damage is contained.
4. Failure on the part of the Client to follow any instructions, requirements or guidelines provided by Concord Industrial Coatings Pty Ltd regarding the proper care and/or maintenance of the coating would immediately void the warranty. This includes but is not limited to all wilful, negligent or accidental behaviour and the treated area being used for activities contrary to its designed purpose whether it be intentional or otherwise.
5. If the coating is repaired or altered in any way, by any persons other than an employee Concord Industrial Coatings Pty Ltd, or without prior written approval from Concord Industrial Coatings Pty Ltd, then the warranty shall cease and Concord Industrial Coatings Pty Ltd will, under no circumstances, be held liable.

WARRANTY AND APPLICATION CONDITIONS
